Individual programs completing a profile will allow the information submitted under Steps 1 and 2 of the profile to become available to the general public. Furthermore, IAA will not display information about individual program needs or challenges to the public. In regards to the

information provided in Step 3, IAA and their affiliates may combine, in a non-identifiable format, the organizational information you provide with information from other users to create aggregate data that does not contain any information that could be used to identify or contact you. This aggregated data can be used to engage and inform civic and community leaders about Iowa afterschool programs' needs and challenges. *We do not sell any information to third party marketing companies.*

### *Security Standards*

We have established and continually maintained security standards and procedures to help us protect confidential information from unauthorized access. This includes a server that is housed at a secure co-location environment, which resides behind a firewall that allows limited access based on login and does not allow unidentified access to the environment. Additionally, system monitoring runs at all times to notify the System Administrator of any suspicious activity.
